# What is FASTrack?

FASTrack is a summer campus residency program designed to introduce high school juniors to careers in finance and accounting. The primary objective of this innovative career development program is to increase the number of high school students from underrepresented groups that attend college and major in accounting or finance. You'll get to live on a real college campus and meet people who share your interests. You'll also visit local businesses and hear from finance and accounting professionals

## How does it work?

During this fully supervised four-day residential program, a select group of students will explore accounting and finance careers through experiential site visits, campus tours, professional roundtables and networking opportunities with professors, business professionals, college students and fellow high school students. You'll get a first-hand look at day-to-day operations of various businesses and opportunities to talk with finance and accounting professionals about what they do. The program concludes with a recognition banquet for students, parents, speakers and corporate partners.



## How much does it cost?

Students are selected to participate in FASTrack free of charge. Students are responsible for their own transportation to and from the University of Kentucky campus.
