





Honors Pathways

The Gatton College offers three highly selective Lewis Honors College Pathways for incoming freshmen: Global Scholars, Social Entrepreneurship Scholars, and Scholars in Engineering and Management. Each pathway has its own signature element which can include opportunities in education abroad, launching a new business rooted in community development and sustainability, and attaining the LEAN systems certification, respectively. These pathways focus on project-based learning and developing leaders who are ready to engage in the business world.

The Lab for Economics and Accounting Proficiency (LEAP)

LEAP is located in the Gatton building and provides free peer tutoring services for students enrolled in economics and accounting courses. This service facilitates student learning and academic success by offering guidance with coursework and reinforcing what is taught in the classroom.



Pre-Major Information

Incoming freshmen are admitted as pre-majors to the Gatton College and are required to complete a series of pre-major courses before being admitted into upper division. Starting as a pre-major allows students to build a foundation of general business principles while solidifying their desired degree path. Not ready to choose a pre-major? No problem.
